**ProVent Plus is available in two coverall styles certified to NFPA 1999, with proven protection designed for healthcare, emergency response and law enforcement personnel.**

**Healthcare and Emergency Response (style PPH439-99 shown at right)** Economical single-use garment ideal for healthcare and emergency response situations where there is potential blood and viral exposure including Ebola and other biohazards. This is the only single-use garment certified to NFPA 1999 while also meeting OSHA and CDC guidelines for biohazard exposure.

**Law Enforcement (style PPH459-99 shown below)** Tactical-style garment designed for law enforcement drug unit response when fentanyl and other bio-particle hazards are potentially present. Provides a cost-effective multi-use, single-exposure alternative to expensive reusable garments. In addition to NFPA 1999 certification, this style also meets PPE Guidance for Fentanyl Exposure issued by IAB and CDC/NIOSH.



Style PPH459-99 includes Sure-Fit® respirator face piece seal and rear entry design to facilitate doffing and reduce cross-contamination.
